- To ensure, equal and without exclusions, access for preschool and school- age children - and especially children in need - to quality education services, in accordance with the specific points of the Council Recommendation EU 2021/1004 about the constitution of a European Child Guarantee.
- The provide access for children, teenagers and people with disabilities to services of creative activities, according to the act 4941/2022/article 104 (Official Journal of the Hellenic Republic no 113/A/16.6.2022).

## THE TYPES OF ESTABLISHMENTS

- Nurseries, Preschool and Childcare Facilities, Extended Care Nurseries
- Centers of Creative Activities for Children
- Centers of Creative Activities for People with Disabilities

All services included in the Programme are provided by entities of both the Public and Private sector (e.g. municipal and private enterprises).

The process regarding placement and voucher allocation to approved beneficiaries will be implemented by the Hellenic Agency for Local Development and Local Governance. Beneficiaries will have the opportunity to indicate the establishment of their choice, as long as it corresponds to the category of their voucher.

## SOURCES OF FUNDING

The programme is co-funded by the European Social Fund+ (ESF+), falling under the National Strategic Reference Framework (NSRF 2021- 2027), national funds and the Regular Budget of the Ministry of Social Cohesion and Family Affairs.

The total budget is estimated to €361.200.000.

The Programme is implemented by the Hellenic Agency for Local Development and Local Government.
